

Ukraine is one of top destinations for surrogacy and egg donation programs, as here the Intended Parents are totally protected by the legislation as if a couple is officially married and if one of a couple is genetically related to a baby the couple is considered to be the biological parents. According to our legislation a surrogate mother can't claim any rights as to the baby and only you as a mother and a father will be indicated in the child's birth certificate.

But to use the surrogacy services in Ukraine you need to fulfil the conditions:

- have medical indications for using surrogacy (certified by the doctor's letter) –
- be officially married (could you please send me the scanned copy of your marriage certificate)
- the parent(s) whose gametes are going to be used for program shouldn't carry a positive status for: Hepatitis B, Hepatitis C, HIV, syphilis

All of the packages are based on our ALL INCLUSIVE program and it means that the contract covers:

- unlimited number of attempts - we will try until you get a baby
- surrogacy program including surrogate mother fee
- egg donor services - most of our donors are European looking, the pool contains more than 800 donors and the database is dynamic - new egg donors constantly appears
- all the medications needed for stimulation (if any)
- personal guidance of a manager in charge of your program
- accommodation and food
- support package (differs depending on the contract, but within any program we meet you in the airport and provide transfer to/from place of accommodation, to/from clinic, to/from maternity hospital)
- legal support on a final stage of the process for obtaining the birth certificate for a baby and travel documents for them to leave the country
- DNA paternity test in our partnering laboratory. If your Embassy requires additional DNA test it is to be covered by the Intended Parents

- the child's doctor attends the baby every other day
- in case of miscarriage, compensation to a surrogate mother is paid by us

- customers are provided with the support package: transportation, food, a room in the hotel of higher class, smartphone and SIM card of Ukrainian mobile operator
- accommodation is provided for two (2) months after birth

- VIP service for the clients in the days of visits (no waiting list, etc/.)
- needed injections are performed by the coming nurse domiciliary - in the apartments where the customers are staying

- customers can be provided with two attempts of mitochondria donation (if comply with medical requirements)
- customers are provided with the NEWBORN PACKAGE - all the things needed to take care of a newborn baby
- customers are provided with the complete physical check up of the baby(s) by the focused specialists
- customers can be present during the delivery (if authorized by the maternity house) and stay with a baby in the maternity hospital in separate room until the discharge
- customers are provided with the babysitter services from 9 o'clock in the morning till 5 o'clock in the evening
- the child's doctor attends the baby everyday, besides if needed this leading pediatrician visits the baby upon the request
- customers are provided with the VIP support package: transportation, food based on the restaurant menu, separate apartment, services of attending housemaid, smartphone and SIM card of Ukrainian mobile operator
- accommodation is provided for four (4) month of your final stay in Ukraine
